providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....

**(512131) -Movie Theaters**

operating motion picture theaters (except drive-ins) and/or exhibiting motion pictures or videos at film festivals, and so forth....

**(484210) -Moving and Storage**

providing local or long-distance trucking of used household, used institutional, or used commercial furniture and equipment. incidental packing and storage activities are often provided by these establishments....

**(722211) -Mr. Gatti's (Pizza)**

providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....

facilitating credit intermediation (except mortgage and loan brokerage; and financial transactions processing, reserve, and clearinghouse activities)....

**(238220) -Mr. Rooter Plumbing**

installing and servicing plumbing, heating, and air-conditioning equipment. contractors in this industry may provide both parts and labor when performing work. the work performed may include new work, additions, alterations, maintenance, and repairs....

**(311999) -Mrs. Fields Original Cookies**

manufacturing food (except animal food; grain and oilseed milling; sugar and confectionery products; preserved fruits, vegetables, and specialties; dairy products; meat products; seafood products; bakeries and tortillas; snack foods; coffee and tea; flavoring syrups and concentrates; seasonings and dressings; and perishable prepared food). included in this industry are establishments primarily engaged in mixing purchased dried and/or dehydrated ingredients including those mixing purchased dried and/or dehydrated ingredients for soup mixes and bouillon....

**(451220) -Music Stores (Music and Instruments)**

retailing new prerecorded audio and video tapes, compact discs (cds), digital video discs (dvds), and phonograph records....

**(561990) -Mystery Shopping Companies**

providing day-to-day business and other organizational support services (except office administrative services, facilities support services, employment services, business support services, travel arrangement and reservation services, security and investigation services, services to buildings and other structures, packaging and labeling services, and convention and trade show organizing services)....

**(812113) -Nail Salons**

providing nail care services, such as manicures, pedicures, and nail extensions....

**(454390) -Newspaper Routes**

retailing merchandise (except food for immediate consumption and fuel) via direct sale to the customer by means, such as in-house sales (i.e., party plan merchandising), truck or wagon sales, and portable stalls (i.e., street vendors)....

**(451212) -Newsstands**

retailing current newspapers, magazines, and other periodicals....

**(623110) -Nursing Homes**

providing inpatient nursing and rehabilitative services. the care is generally provided for an extended period of time to individuals requiring nursing care. these establishments have a permanent core staff of registered or licensed practical nurses who, along with other staff, provide nursing and continuous personal care services....

**(424120) -Office Products**

the merchant wholesale distribution of stationery, office supplies and/or gift wrap....

**(453210) -Office Supplies and Stationery Stores**

one or more of the following: (1) retailing new stationery, school supplies, and office supplies; (2) selling a combination of new office equipment, furniture, and supplies; and (3) selling new office equipment, furniture, and supplies in combination with selling new computers....

**(453310) -Once Upon A Child**

retailing used merchandise, antiques, and secondhand goods (except motor vehicles, such as automobiles, rv's, motorcycles, and boats; motor vehicle parts; tires; and mobile homes)....

**(446130) -Optical Practices**

one or more of the following: (1) retailing and fitting prescription eyeglasses and contact lenses; (2) retailing prescription eyeglasses in combination with the grinding of lenses to order on the premises; and (3) selling nonprescription eyeglasses....

**(446130) -Optical Shops**

one or more of the following: (1) retailing and fitting prescription eyeglasses and contact lenses; (2) retailing prescription eyeglasses in combination with the grinding of lenses to order on the premises; and (3) selling nonprescription eyeglasses....

**(621320) -Optometry Practices**

this industry comprises establishments of health practitioners having the degree of o.d. (doctor of optometry) primarily engaged in the independent practice of optometry. these practitioners provide eye examinations to determine visual acuity or the presence of vision problems and to prescribe eyeglasses, contact lenses, and eye exercises. they operate private or group practices in their own offices (e.g., centers, clinics) or in the facilities of others, such as hospitals or hmo medical centers, and may also provide the same service as opticians, such as selling and fitting prescription eyeglasses and contact lenses....

**(722211) -Orange Julius**

providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....

**(561910) -Packaging (Industrial)**

packaging client-owned materials. the services may include labeling and/or imprinting the package....

**(444120) -Paint & Decorating (Wallpaper) Retailers**

this industry comprises establishments known as paint and wallpaper stores primarily engaged in retailing paint, wallpaper, and related supplies....

**(561431) -Pak Mail**

this u.s. industry comprises (1) establishments primarily engaged in providing mailbox rental and other postal and mailing (except direct mail advertising) services or (2) establishments engaged in providing these mailing services along with one or more other office support services, such as facsimile services, word processing services, on-site pc rental services, and office product sales....

providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....
