### **(323114) -Print Shops/Quick Print**

traditional printing activities, such as short-run offset printing or prepress services, in combination with providing document photocopying service. prepress services include receiving documents in electronic format and directly duplicating from the electronic file and formatting, colorizing, and otherwise modifying the original document to improve presentation. these establishments, known as quick printers, generally provide short-run printing and copying with fast turnaround times....

### **(323112) -Printing/Flexographic**

flexographic printing without publishing (except books, grey goods, and manifold business forms). this industry includes establishments engaged in flexographic printing on purchased stock materials, such as stationery, invitations, labels, and similar items, on a job order basis....

### **(541430) -Printing/Silk Screen**

planning, designing, and managing the production of visual communication in order to convey specific messages or concepts, clarify complex information, or project visual identities. these services can include the design of printed materials, packaging, advertising, signage systems, and corporate identification (logos). this industry also includes commercial artists engaged exclusively in generating drawings and illustrations requiring technical accuracy or interpretative skills....

### **(445230) -Produce Markets**

retailing fresh fruits and vegetables....

### **(531312) -Property Management Companies (Non-residential)**

managing nonresidential real estate for others....

### **(511130) -Publishers -- Books**

this industry comprises establishments known as book publishers. establishments in this industry carry out design, editing, and marketing activities necessary for producing and distributing books. these establishments may publish books in print, electronic, or audio form....

### **(514191) -Publishers -- Internet (and Broadcasting)**

this industry comprises establishments known either as magazine publishers or periodical publishers. these establishments carry out the operations necessary for producing and distributing magazines and other periodicals, such as gathering, writing, and editing articles, and selling and preparing advertisements. these establishments may publish magazines and other periodicals in print or electronic form....

### **(511120) -Publishers -- Newsletters**

this industry comprises establishments known either as magazine publishers or periodical publishers. these establishments carry out the operations necessary for producing and distributing magazines and other periodicals, such as gathering, writing, and editing articles, and selling and preparing advertisements. these establishments may publish magazines and other periodicals in print or electronic form....

### **(511110) -Publishers -- Newspapers--Dailies**

this industry comprises establishments known as newspaper publishers. establishments in this industry carry out operations necessary for producing and distributing newspapers, including gathering news; writing news columns, feature stories, and editorials; and selling and preparing advertisements. these establishments may publish newspapers in print or electronic form....

### **(511110) -Publishers -- Newspapers--Weeklies/Community Papers**

this industry comprises establishments known as newspaper publishers. establishments in this industry carry

out operations necessary for producing and distributing newspapers, including gathering news; writing news columns, feature stories, and editorials; and selling and preparing advertisements. these establishments may publish newspapers in print or electronic form....

**(511210) -Publishers -- Software**

computer software publishing or publishing and reproduction. establishments in this industry carry out operations necessary for producing and distributing computer software, such as designing, providing documentation, assisting in installation, and providing support services to software purchasers. these establishments may design, develop, and publish, or publish only....

**(511110) -Publishing -- Newspapers (in general)**

this industry comprises establishments known as newspaper publishers. establishments in this industry carry out operations necessary for producing and distributing newspapers, including gathering news; writing news columns, feature stories, and editorials; and selling and preparing advertisements. these establishments may publish newspapers in print or electronic form....

**(51) -Publishing (In General)**

the sector as a whole the information sector comprises establishments engaged in the following processes: (a) producing and distributing information and cultural products, (b) providing the means to transmit or distribute these products as well as data or communications, and (c) processing data. the main components of this sector are the publishing industries, including software publishing, and both traditional publishing and publishing exclusively on the internet; the motion picture and sound recording industries; the broadcasting industries, including traditional broadcasting and those broadcasting exclusively over the internet; the telecommunications industries; the industries known as internet service providers and web search portals, data processing industries, and the information services industries. the expressions "information age" and "global information economy" are used with considerable frequency today. the g...

**(811118) -Purrfect Auto**

providing specialized mechanical or electrical repair and maintenance services (except engine repair and replacement, exhaust systems repair, and transmission repair) for automotive vehicles, such as passenger cars, trucks, and vans, and all trailers....

**(453220) -Pushcarts**

retailing new gifts, novelty merchandise, souvenirs, greeting cards, seasonal and holiday decorations, and curios....

**(722211) -Quaker Steak & Lube**

providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....

**(722211) -Quizno's Classic Subs**

providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....

**(711212) -Race Tracks/Auto**

operating racetracks. these establishments may also present and /or promote the events, such as auto, dog, and horse races, held in these facilities....

**(713940) -Racquet Sports Clubs (Also includes Health and Fitness Centers)**

operating fitness and recreational sports facilities featuring exercise and other active physical fitness conditioning or recreational sports activities, such as swimming, skating, or racquet sports....

**(513112) -Radio Stations**

**(531210) -Real Estate/Business Brokerage Offices**

acting as agents and/or brokers in one or more of the following: (1) selling real estate for others; (2) buying real estate for others; and (3) renting real estate for others....

**(541611) -Records Management**

providing operating advice and assistance to businesses and other organizations on administrative management issues, such as financial planning and budgeting, equity and asset management, records management, office planning, strategic and organizational planning, site selection, new business startup, and business process improvement. this industry also includes establishments of general management consultants that provide a full range of administrative; human resource; marketing; process, physical distribution, and logistics; or other management consulting services to clients....

**(722211) -Red Robin Gourmet Burgers**

providing food services (except snack and nonalcoholic beverage bars) where patrons generally order or select items and pay before eating. food and drink may be consumed on premises, taken out, or delivered to the customer's location. some establishments in this industry may provide these food services in combination with selling alcoholic beverages....

**(523930) -Registered Investment Advisors**

providing customized investment advice to clients on a fee basis, but do not have the authority to execute

trades. primary activities performed by establishments in this industry are providing financial planning advice and investment counseling to meet the goals and needs of specific clients....
